RATIONALE AND SUMMARY (TWO PAGES):

ISSUE:

National Security requires an Economic Freedom & Prosperity Message and Action Plan - to be announced by The President, Executive Branch & Congress. This Soft Power Initiative enables and spurs 'citizen patriots abroad,' who have a material stake in their lives and livelihoods, to counter and take down their oppressors. Given hope and economic security, they will counter oppressors who endanger their children's lives and dominate and control their neighborhoods and communities: dictators, terrorists, youth gangs, criminals and militias. Given secure independent livelihoods, they will counter infiltrators who attack them from across their borders: Homicidal Suicide bombers, drug dealers, arms dealers, foreign mercenaries, and terrorist networks.

Over time positive results from Economic Freedom & Prosperity Initiatives should relieve the U.S. from having to intervene militarily. Accordingly, U.S. Economic Power must be harnessed for National Security purposes -- as has been done with Military, DHS, Intelligence, and Center for Disease Control operations. (See: Page 63 Commentary by World Authorities: Economic Freedom).

To guide U.S. policy, the President will appoint a White House Director who will head up the Economic Freedom & Prosperity Initiative. The Director, reporting directly to the President, oversees, coordinates and administers an Economic Freedom Hub Strategy Center. Working collaboratively, U.S. government and agencies advise the Director on feasible strategies to advance the Economic Freedom & Prosperity Initiative. They design and implement operations within their purview so that they maximize the overall impact of the Initiative. Without Economic Freedom & Prosperity abroad -- that diminishes, deters and eventually overcomes Terrorism, Islamofascism, Poverty, and Human Rights Atrocities -- the military option will always be exercised with much higher frequency.



REQUIREMENT:

Next Step: The President after counseling with Congress, creates and announces a Cohesive Interagency Freedom Strategy Center [Unified Action Plan]. Responding to the White House Director, the Center team aligns and harnesses programs and operations, proposed and effected by U.S. departments and agencies.

RATIONALE SUMMARY:

Proven, "hands on," low cost Economic Freedom & Prosperity initiatives, with proper and fitting cost effective measures and standards, are strategically established as a coherent "decisive" tactical and operationally effective Action Plan.

BOTTOM LINE:

Without creating a comprehensive Economic Freedom & Prosperity Action Plan - Hub Strategy Center, led by a White House Director, highly versed in areas of economic reform, business transparency and diplomacy as paths to diffusing economic power to total national populations, the execution of United States Foreign Policy is seriously jeopardized. 21st Century Foreign Policy would likely die a Wilsonian Doctrine death, a Doctrine that takes for granted Economic Freedom and Prosperity for all a nation's people. END

EXECUTIVE SUMMARY ACTION PLAN: Pages 56 - 62

Establishing an Economic Freedom and Prosperity Dimension will be a Primary Initiative in U.S. Foreign Policy. The Action Plan for Economic Freedom and Prosperity will enlist the civilian and military elements of the U.S. Foreign Affairs Corps in spreading the message of individual liberty, economic freedom, independence and prosperity worldwide. It sets in place a model for the United Nations to emulate, bringing nations together on key and important issues of peace, security, freedom, independence, prosperity and environmental sustainability.

Freedom and Independence must become an integral part of the daily lives of Ordinary People abroad. This happens when Economic Freedom and

individual prosperity begin to take hold. As nations liberalize economic conditions, from small cottage industries to larger local businesses to big metropolitan enterprises, everyone will improve their chance to exchange goods and services, secure their livelihoods, send the kids to school and contribute to neighborhood and cross-border peace and general prosperity.

Having a material stake in their own future, Ordinary People in emerging countries will be ready and willing to defend their neighborhoods and local communities against insurgents, malicious terrorists and cruel, underhanded oppressors and dictators. The peoples' tools and levers of power will be safe secure streets, open viable markets, titled property rights and valid contracts, enforced through just law, independent judges, honest sheriffs, transparency and a free press.

The Economic Freedom and Prosperity Unified Action Plan reflects the counsel of General David Petraeus who calls for SECURING AND ENGAGING THE POPULACE to win "HEARTS AND MINDS." THE STRATEGY ADVANCES NATIONAL INTELLIGENCE DIRECTOR MIKE McCONNELL'S NATIONAL SECURITY MISSION.

Most importantly, populations abroad, when empowered with Economic Freedom & Prosperity, possess capabilities and drive to diminish, deter and eventually put to rout Terrorism, Poverty, Crime and Human Rights Atrocities. They cause their governors to serve the people, rather than entrenched, traditional power groups. Once discovering they are stakeholders in their own lives and livelihoods, patriots will start taking down their near-by and far-off oppressors. They will be more ready to work on Regional Sustainable Development Programs and projects in their region. Consequently, the U.S. military option or UN peacekeeping forces will not have to be exercised as often in countries where populations at large have individual Economic Freedom and Prosperity.

The Economic Freedom Unified Action Plan will be overseen by the White House Director who heads up the White House Freedom Strategy Hub. The Economic Freedom approach with a White House Hub will maximize and encourage cooperation between USG agencies and departments that have

differing responsibilities, functions and funding sources.

The U.S. Foreign Service Corps will become highly versed in modalities of Economic Freedom & Prosperity. Armed with this knowledge, the Corps, civilian and military, will help empower people at large in any selected Middle East or other country, including Iraq and Afghanistan. Operations extend to: China, Russia, Korea, Brazil and other key countries.

Altogether the White House Hub team guides policy and strategy for a cohesive practical Economic Freedom and Prosperity Initiative.

Retooling Economic Freedom To Achieve White House Goals:

- White House Hub Centralization: Provide policy and oversight for the plans and operations of departments and agencies as they develop, administer, and implement Economic Freedom & Prosperity Initiatives, with viable data base analysis, dissemination, and interagency feedback.
- White House Hub Mobilization: Provide oversight for the plans and operations of departments and agencies which give directional finding tools for the Foreign Affairs Corps and the Joint Military Civilian Operations personnel on the President's mission, strategy and tactics in an Unified Economic Freedom & Prosperity Action Plan.
- White House Hub Decentralization: The Economic Freedom & Prosperity Dimension Unified Action Plan is not only strategically and collaboratively administered, but is soundly handled logistically on the Unified Action Plan Tactical Level within each department and agency and with ground operations personnel.

Accordingly, The White House Director/Coordinator establishes a Senior Interdepartmental Group (SIG) and subordinate Interdepartmental Groups (IGS) to coordinate outreach to the public. (The Members of these SIG's shall be the senior speech writers in each department and/or agency. The objective is to have the speeches of each agency reference and or echo the President's themes as appropriate.) He/ she collaborates with the SIGs and IGs to align and harmonize the content and context of each executive agency's current message with the President's relevant speeches and where relevant the theme of the President's Economic Freedom message for each of their respective agencies and departments.

CABINET LEADERSHIP: Quite importantly, to ensure the President's Economic Freedom & Prosperity Initiative is launched in each U.S. Foreign Affairs agency and department, Cabinet Level members will work directly with the White House Initiative Director/Coordinator to convey the President's Directive as policy, and communicate policy, to undersecretaries and ground operations personnel.

Each Cabinet Level Official will take the President's Official words and speeches providing their own commentary on what this means in terms of "Official Policy" work of the departments or agencies they supervise.

Iraq & Afghanistan: It is key for Iraqi and Afghan provincial and local leaders to interact and engage with central government officials to decide on changes that will bring small as well as large entrepreneurs into local, regional and national markets, cross-border trade, and capital formation. To facilitate such exchanges, the U.S. Foreign Service Corps (Reconstruction, Economic, Development and Diplomatic professionals) and Provincial Reconstruction Teams (PRT's) can encourage "Exploratory discussion" and "Constructive Dialogue," particularly discovering ways to speed up commercial exchanges between market towns, hub cities and ports.

It is also key for Iraqi and Afghan entrepreneurs, together with provincial and local leaders, to work with central authorities to introduce sound free market practices and institutions (e.g., rule of law, regulations, tax laws, contracts, provision for private property, judiciary and police systems.) These institutions lay the foundation for robust Economic Freedom to materialize in a country, both in national spirit and practice.

As to budget considerations, the Economic Freedom & Prosperity Initiative recommends a shift in priorities among U.S. operations already underway by competent professionals, with some additional incremental budgetary increases. Such competent officials work at the Center for International Private Enterprise CIPE. Others work as advisors sent by the Departments of State, Defense, Commerce, Treasury, Justice and Agriculture.

IRAQ BOTTOM/UP ACTION PLAN EXAMPLE

The current line of thinking at the U.S. Iraq Embassy and the State Department does not advance a Civil Opportunity Society based on the goals and objectives on an Economic Freedom & Prosperity Initiative. The transformed society will be interlocked by market towns, cross-border trade and investment. Today U.S. objectives should be geared toward enabling the citizens in countries of the Middle East and other regions to build an enduring sovereign nation, undergirded by a Civil Opportunity Society.

For Iraqis, personal independence will grow when they produce and buy more of their own food supplies and necessities from commercial sources, e.g., local bizarres, hub markets, neighboring towns and cities. The U.S. Country Team will be reporting news concerning Iraqi government efforts to promote commerce between Iraqi local and provincial areas and abroad. The reports will keep the White House Hub and State Department up-to-date on efforts of local, provincial and central government leaders and officials to promote indigenous diversified broad based industry. As small – large businesses diversify, populations become less dependent on petro-oil rations for their livelihood.

Here are examples of news regarding the development of free market business institutions and infrastructure that the U. S. Embassies can cover in its regular reports to the White House Hub and State:

- 1. Timely topics of the Iraq Business Council [IBC] Agenda. The IBC represents business associations, Chambers of Commerce, and economic think tanks throughout Iraq [Shiite, Kurd, Sunni and others]. The Council agenda includes:
 - A) Legislative issues on vertically integrated agri-business and other sectors of commerce and trade that the IBC is currently reviewing.
 - B) **P**riority issues in the IBC's National.

IRAQ BOTTOM/UP ACTION PLAN EXAMPLE

Here are examples of news regarding the development of free market business institutions and infrastructure that the U. S. Iraq Embassy can cover in its regular reports to the White House Hub and State:

- **2. T**opics on Iraq Business Talk Television /Radio shows that draw active Iraqi responses and questions on such issues as reconstruction, inflation, privatization, unemployment and proposed oil cash payments into private accounts for every Iraqi citizen.
- **3.** Issues and policies examined at University Round Table Programs e.g. Baghdad University and think tanks. The Embassy can report views and proposals heard from members of the business-agricultural community, academia, media, policy makers and other stake holders on constructive ways to build free markets and a participatory Iraq democratic system.
- **4.** Embassy "Exploratory Discussions" can commence on the Iraq Private Oil Revenue Accounts in an Inviolable Fund for every adult man and women.
- 5. Embassy personnel can become acquainted with the nature of training programs of business association executives and board members. Reports can cover the free market principles and opportunities that business associations are making known to local and regional communities.
- **6.** The Embassy can look into the ways the 30 political parties are learning about issues of economic reform, attending business training programs, and learning through computer exercises that simulate difficulties experienced in nation building.
- 7. The Embassy can become versed on the content and import of polls being conducted [on 1,000 business owners throughout Iraq] regarding opinions and views concerning the business climate and regulatory

changes taking place in the country.

NOTE: SURVEYS ARE SHOWING THAT THE IRAQI BUSINESS COMMUNITY IS OPTIMISITIC REGARDING THE COUNTRY'S ECONOMIC PROSPECTS. However, they are noticeably WARY ABOUT THE GENERAL LEVEL OF CORRUPTION and what can be done about it.

ON TERRORISM: In countering terror operations, America must rout out, take down and eliminate terrorists. America must also do what it can to "drain the swamps" of idle misdirected, disenchanted youth who serve Islamofascists as couriers and suicide bombers. - 1) Work with Heads Of State to implement institutional reforms
- 2) Enable Governors to institute a comprehensive and all-inclusive property rights system
- 3) Enable provincial and local leaders to implement programs to create and manage Legal Property Rights Systems
- 4) Advance property rights and business organizations giving citizens the ability to obtain an identity in the expanded market
- 5) Give the poor access to property rights
- 6) Address the most pressing economic and social problems stemming from the failure of government programs
- 7) Allow both physical and intellectual assets to be converted into capital
- 8) Allow poor and marginalized people to govern their rights collectively e.g., dividing labor, combining assets
- 9) Provide an effective means to title small businesses
- 10) Provide a means to enforce rules and contracts
- 11) Move business and real estate holdings from the underground economy into the economic mainstream
- 12) Provide a real solution to offset failure of various economic systems by using media to demonstrate to each social group the benefits of formalization, whether it be extralegal, the business community, the bureaucracy, or other specific groups
- 13) Allow beneficiaries of assets easy transfer of entitled assets.

When leaders and people of a country engage, embrace, protect and defend each other with Economic Freedom in a Civil Opportunity Society, these OUTCOMES happen:

- 1. Constitutions are written with checks and balances;
- 2. Court systems are developed and supervised with honest judges who fairly and equally uphold the law for all citizens; and an efficient and transparent Civil Service system established
- 3. Even handed systems of sheriff and police enforcement are established; the Professional Military Security Force is neutral and impartial
- 4. All-inclusive titled property rights are protected and defended;
- 5. Free independent press reigns;
- 6. Free elections are held with independent commissions;
- 7. Transparent governments are formed, an independent Central Bank is established, and a currency is established and stabilized;
- 8. Standards and practices are instituted and enforced with a Rule of Law;
- 9. Individual ownership and individual enterprise flourish and are respected;
- 10. Privatization is viewed as a viable alternative;
- 11. Basic education is deemed essential and honored for all citizens;
- 12. Religious customs and cultural heritage are fully respected, honored and protected.

12 Living Elements of a Free-Market - Civil Opportunity Society

In accord with White House policy and guidance, Foreign Affairs Civilian and Military agencies and departments will engage Foreign Nationals, including ordinary people, in constructive dialogue. Drawing on their experience and diplomatic skills, the Foreign Affairs Corps will be a key catalyst for change.

Our Foreign Affairs Corps, with Country Presidents, Prime Ministers and Ambassadors, can create positive and 'compatible Economic Freedom value' conversations which embrace the country's local heritage, national customs and religious traditions. Personal exchanges will entail "exploratory discussions" and "in-country dialogues" concerning the 12 Living Elements of a Free-Market - Civil Opportunity Society. It is in this vein that all peoples can come to understand the 'process of democracy' as a means to achieve Economic Freedom, independence and sovereignty.

It is a Civil Opportunity Society that adheres to civil principles, uniform practices, established law, traditional liberal education and free social / political / economic intercourse for all citizens. The outcome offers an Opportunity Society for all peoples in a country or region to partake and to flourish in a robust economy. This effort goes beyond failed or failing states, and extends to countries like Brazil, Columbia, Peru, Mexico, Iraq, Egypt, Bahrain, Jordan, Afghanistan, Russia, China and India.

As Foreign Nationals and "ordinary people" engage, embrace, protect and defend the 12 Living Elements of a Civil Opportunity Society for Economic Freedom, the New U.S. Economic Freedom and Prosperity Initiative establishes itself as a stark contrast to Wilsonian Foreign Policy.

On February 5, 2005, Condoleezza Rice on route to Ankara made clear that the "Basics of Democracy" lie in: 1) "strengthening the role of an independent judiciary" 2) "strengthening the rule of law," and 3) "permitting a free and independent press to flourish." These are three elements of a successful and an accountable Civil Opportunity Society. In addition, Economic Freedom is an essential ingredient for democracies that will endure. Country leaders, Prime Ministers, Ambassadors and national business leaders and think tanks can honor and protect the ordinary person's inherent rights with Economic Freedom. If country leaders precipitously form governments that eschew the cornerstones of a private property rights system and a substantive judiciary system, they face the

The Critical & Missing Component In USG Soft Strategy

- 1) THE ECONOMIC FREEDOM INITIATIVE OF FOREIGN POLICY LED BY THE PRESIDENT, CONGRESS AND EXECUTIVE BRANCH UNIFIED ACTION PLAN:
 - A) Firmly establishes the United States foreign policy of Economic Freedom and Prosperity as being clearly distinct from President Wilson's call for 'democracy in the world'
 - **B**) **D**efines basic foreign policy in terms that resonate with Ordinary People in America and abroad
 - C) Makes clear the "human" focus of Public Diplomacy

In Philosophical TERMS: The 'Economic Dimension' strategy extricates the United States from the pitfalls of Wilsonian philosophy. The Wilsonian philosophy emphasizes the democratic political process but obscures the hopes and fears of Ordinary People who yearn for Economic Freedom and Prosperity. That is, the hopes and fears of people are: safe streets, home ownership, freedom of expression and religion, and the chance to be free to pursue their personal dreams. The Wilsonian philosophy has led statesmen to champion regime change, "large, costly and partially functional infrastructure" as symbols of stability, and political institution reforms, elections & bicameral legislatures. But it has taken for granted an enduring middle class.

The Economic Freedom and Prosperity Initiative brings forth life giving economic building blocks for Freedom, Security and Prosperity such as:

All-inclusive titled private property rights

Enforced rules of law that are just, fair and equal

Freedom of Expression and Religion

Limited and Transparent Government



IN IDEOLOCIAL TERMS: The 'Economic Freedom & Prosperity Initiative' strategy extricates the United States room the pitfalls of Wilsonian philosophy.

Because it does not establish and shore up economic institutions in a sound, viable and culturally germane way, the Wilsonian philosophy does not result in sustained economic growth for the people at large. It leaves people far short of the economic independence and personal prosperity they crave in a Civil Opportunity Society.

- 2) COHESIVE INTERAGENCY STRATEGY ORGANIZATION & MANAGEMENT PROVISION: Cohesive U.S. Interagency Strategy Integrates, Fine Tunes and Innovates the Economic Dimension of U.S. Foreign Policy Soft Strategy. The White House State Hub Center develops overall strategy and oversees ongoing operations to centralize, mobilize, and disseminate information on Economic Freedom. Principal USG leaders collaborate to set strategy and harness the current resources of their respective departments, in league with the Hub Strategy Center. Responding to Presidential Directives, Congressional Directives and Appropriation guidelines, USG principal department leaders:
 - A) Assign key 'economically versed' personnel
 - **B**) **D**efine clear objectives, strategies and tactics for performance
 - C) Activate reporting interagency methods and feedback systems
 - **D**) Establish sound performance standards and ratings
 - **E**) **S**et up and apply benchmarks and systematic review criteria
 - **F**) Work within the guidelines and standards of the White House Hub Strategy Center

Foreign Affairs personnel, once oriented in courses on free markets and institutions that bring the informal sector on board, become the public sector media for Freedom and Liberty messages. Private Sector plays a similar role.



3) <u>COMPONENTS OF ECONOMIC FREEDOM & PROSPERITY</u> SOFT STRATEGY INITIATIVES

Large Cash Outlays for infrastructure development are NOT needed to launch the Economic Freedom & Prosperity Soft Strategy Initiative:

Foreign Affairs Corps department heads and personnel, wherever stationed or assigned, will lead the economic initiative in 'active' public diplomacy.

The White House Hub Economic Freedom strategy in good part calls for replicating and extending a number of already PROVEN overseas programs, private and public. Examples are:

G) Role Of U.S. Trade Representative [USTR]: Ambassador Robert Zoellick, former U.S. Trade Representative [2001- 2005], and Ambassador Ashley Wills, former Deputy USTR, ironed out bilateral Trade Agreements around the world which further liberalized local & national business conditions and promoted Freedom and Liberty. These Trade Agreements opened up Opportunity for larger factions of country populations to take part in national and global markets. These agreements take their toll on terrorism.

Since 2004, the U.S. completed and implemented ten free trade agreements with Chile, Singapore, Australia, Morocco, CAFTA-DR Republic) and Bahrain. Now USTR, with U.S. Foreign Affairs experts, can review recent Indexes of Economic Freedom to identify other elements of economic reform that can be introduced into negotiations for new free trade agreements. Examples of such reforms could be: 1) changes of regulations to stimulate in-country entrepreneurship and 2) changes useful for establishing and protecting private property rights.

H) Today Ambassador Susan Schwab USTR [2006 – Present] can continue advancing Economic Freedom and Prosperity with the negotiations of new agreements [bi-lateral, multilateral and sectoral] and renewal of old agreements; and Ambassador Zoellick, World Bank President, can encourage Economic Freedom and Prosperity.
